BIOLOGY AND HABITAT

Species description (Read more)

Squids are cephalopods in the superorder Decapodiformes with elongated bodies, large eyes, eight arms and two tentacles. The European squid belongs to the family of *Loliginidae*.

Geographical distribution and habitat (Read more)

The European squid is an abundant species, among the most landed fishery products in the global seafood market. It lives in coastal waters throughout the Atlantic (Northeast, Eastern Central, and Southeast), as well as in the Mediterranean and Black seas.

RESOURCE, EXPLOITATION AND MANAGEMENT

Stock and resource status/conservation measures

There is no conservation measure for the European squid except a technical measure that sets minimum mesh size at 40 mm for direct squid fishing (Regulation (EU) 2019/1241).

Production methods and fishing gears (Read more)

The main fishing gears used are the trawls. Other gears include beach-seines, gillnets, and trammel nets.


Evolution of world catches

• Squid catches reached over 3.000.000 tonnes in 2021 (the European squid catches amounted to 2.216 tonnes and this species was exclusively caught by the EU fleet). The main producers were China and Peru, representing half of the global catches in 2021, followed by Indonesia, Taiwan and India (respectively 7%, 5%, and 5% of the global catches). The EU catches represented 1% of the global captures in 2021. During the last decade (2012-2021), squid catches have slightly decreased (-3%) at global level.

• Squid catches in the EU reached over 39.700 tonnes in 2021, catches of the European squid species reached over 2.200 tonnes. Spain was by far the main producer, representing two thirds of the EU catches, followed by France and Portugal (respectively 11% and 9% of the catches). During the last decade (2012-2021), EU squid catches have significantly decreased (-38%) in relation to the decrease of the Spanish catches (-39%).




TRADE

• **Extra-EU imports** reached over 232.500 tonnes in 2022, of which 98% were frozen. In 2022, EU imports originated mostly from the Fakland Islands (30% of the volume imported) and to a lesser extent from India and China (respectively 18% and 11% of the volume imported). The same year, the main importers within the EU were Spain (64% of the imported volume) and Italy (19%).

Main importers (2022, in tonnes)




Main EU suppliers (2022, in tonnes)




Extra-EU exports:

In 2022, export volumes of squid totaled 37.886 tonnes. Exports were made almost exclusively of frozen squids (98%). Spain was by far the first EU exporter, representing 93% of the exported volume. Other EU exporters included Italy, Portugal, and Greece, representing 6% of the EU exported volume in 2022. China, Morocco and South Korea were the main destination markets, representing 68% of EU exports.

Main destinations (2022, in tonnes)




